#### Tourney Information

- Boys Gold Division Group Winners will advance to Semifinals based on points;
  - Semifinals will be determined by tourney committee to avoid regular season matchups, etc.
  - Tourney staff reserves right to make semifinals work in terms of volunteers and teams playing
- Boys Silver Division Group A Winner will face Group B Winner in the Championship;
- Boys Gold & Silver Division 4<sup>th</sup> matches will be determined by tourney committee;
  - Nansemond River (VA) cannot play a 4<sup>th</sup> match, thus there will be no game for this opponent
- Girls Division will feature Round-Robin play with the Champion and Runner-Up awarded via points system;
- Boys Semifinals & Championship along with some placement games will be played on Wednesday.

#### Tournament Format & Rules

All teams are guaranteed THREE matches (provided weather cooperative). There is no refund should the tourney should be canceled at any time due to weather. We will make every reasonable effort to play, but player safety will be paramount. Saluda Shoals Complex administered by Irmo-Chapin Rec Commission can suspend/cancel play at any time.

The tourney will feature two forty-minute halves with a 7-minute halftime. SCHSL rules apply. We will observe a 'running clock' and only stop the clock on severe injuries and after a goal is scored.

A Grace Period of 10 minutes will exist in order to start all matches. If a team is not present 10 minutes from kickoff, the match will be scored as a forfeit.

Forfeits in the tournament will receive a score of 1-0 and be awarded 8 points to the winner.

Team listed first will wear DARK kits. Teams listed second will wear WHITE/LIGHT kits.

There will be ties and no overtime - except for the Semifinals and Championship match, which will be decided by the SCHSL regular season procedure of two five-minute overtime periods and then a penalty kick shootout, if not already determined.

An Athletic Trainer will be on site. If players need to be taped, they must bring their own tape and report to the medical tent at least 20 minutes prior to their scheduled kickoff.

There will be a water cooler placed at each field for teams to use. Each team should provide their own water bottles.

Tournament balls will be provided for each match and should be returned to midfield after each game.

### Points System

The following points system will be followed (10 points maximum for each match):

- 6 points for a win
- 3 points for a tie
- 1 point for every goal up to three
- 1 point for a shutout
- 0 points for a loss
- -1 point for an accumulated red card (two yellow cards)
- -2 points for a straight red card
- Any forfeit will be recorded as 1-0, with 8 points going to the winner.

If, at the completion of group play, a tie in the standings exists in determining the group champion, the following criteria shall be used to determine the champion:

- Head-to-head competition
- Goals Allowed
- Goal Differential - Goals scored minus goals allowed, with a maximum of five goals per game.
- Goals For (max of 5)
- Penalty Kick Shootout

Awards will be presented to the Champion and Runner-Up teams, as well as the tourney MVP.
